CUSTOMER BACKGROUND:

The British Film Institute (BFI) is a British institution and is the country's leading organisation for film and media. Operating as an artistic charity, the BFI curates and presents the greatest international public programme of world cinema for audiences virtually, in cinemas and at festivals. Working with government and industry to actively seek out and support the next generation of filmmakers, the BFI is also home to the most noteworthy media archive in the world. A source of historic artistic value, the BFI National Archive requires complex environmental factors to be taken into consideration to ensure the preservation of its contents.

THE SITUATION:

The BFI needed a service provider who fully understood their environmental requirement in managing a Building Energy Management System (BEMS) that accurately controls archives at -5 Degrees C at 0.8g/Kg moisture content under very tight tolerances.

This type of critical environment historically preserves the cellulose nitrate films (commonly known as celluloid) for the future. Any deviations to this can over a period of time degrade the material, and at worst, can create explosions and poisonous gas. The client required a service provider who could enhance and maximise operational efficiencies while maintaining the precise quality and stability of the environment.

THE REQUIREMENT:

To meet the customers requirement, Kendra visit the site for PPM every two weeks to coincide with the FM Contractor. The site is connected through Kendra's innovative Bureau to ensure that remote connectivity is fully available 24/7 via our Kendra's hosted cloud technology. This allows immediate accessibility and enhanced security via a duo-factor application.

All panels are regularly inspected and surveyed with a thermal imaging camera to check for any future operational equipment failures, in order to make sure that the archive remains consistently managed, controlled and protected.
